The programme was conducted in physical mode in VAMNICOM, Pune.

Dr. D. Ravi, Consultant, CICTAB inaugurated the programme and interacted with participants. He briefed about the programme outline.

#### **Group photo and interaction session:**

Dr. Hema Yadav, Director, VAMNICOM interacted with the participants in group photo session. Director shared that most basic ways to measure a product's potential in foreign markets is its success in domestic markets. Cooperatives first identify the market where there is demand for their product. Then they have to study product standards and as per their standard produce the product to serve in foreign market. Ministry of cooperation formed a export federation to help the cooperatives in exportation.

#### **Objective of the Programme**

The broad objectives of the programme was:

- To sensitize the participants about the knowledge on international marketing and learn export related procedures to enter into an expanding new market and avail the new business opportunities for cooperatives
- To provide knowledge on Agri-Export procedures & documentation.

#### **Coverage of the Programme**

The training programme was for Chief Executive Officers / Senior Executives of Agricultural Banking, Rural Financing Institutions, Cooperatives and Rural Development Organisations / Institutions in the Countries of the SAARC Region. The 4-day long programme comprised of 12 sessions of 1 hour 15 mins minutes duration each on the following broad topics:

**Day 1: 8th January 2023** 

#### **Session -1**

## **Topic:** Identifying the agri and horticulture products for export **Faculty/Resource person:** Dr. Mahesh Kadam, Faculty, VAMNICOM

Dr. Mahesh Kadam addressed that supply side constraints have hindered production, and in turn the export of agro-products, making Nepal a net-importer of agriculture goods. Further he explained that how to select the agricultural commodity for export. At time of selection of product strictly check the government policies related to the export of a particular product. Though there are very few restrictions in export - it is better to check regulatory status of your selected product.

Carefully study the various government incentive schemes and tax exemption like duty drawback and DEPB. Import regulation in overseas markets, specially tariff and non-tariff barriers. Though a major non-tariff barrier (textile quota) has been abolished - there are still other tariff and non-tariff barriers. If product attracts higher duty in target country - demand obviously falls.



#### Session -2

#### Topic : Agri Export Procedures and Documentation for Cooperatives Faculty/Resource person : Shri Sudhir Chitrakar, Director, Swayambhu Exim

Shri Sudhir Chitrakar explained that there are many policies for export the agricultural produce. Like EXIM, Export Incentive Scheme, Duty Remission Scheme, Government-Grant-In Aid and Subsidy. Steps to start the export business he explained. How procedures documentations and to be followed for exportation also he briefly explained to the participants with help of example of Mango export from India to other countries.



#### **Session -3**

# Topic: Warehouse Management Faculty/Resource person: Shri Sameer Nadgauda Storage superintendent, MSWC

Shri Sameer Nadgauda briefed about the role of the storage facility in the export and inport business. He further explained that Warehousing and inventory storage are key components within both the logistics and supply chains. Used by customs, transporters, manufacturers, wholesalers and import / export companies they enable the storage and distribution of raw materials and finished goods, as well as everything in-between. He also suggested to the participants that they can start the warehouse business at their cooperatives.



Day 2: 9th January 2023

#### **Session -4**

#### **Topic : Custom Procedures**

#### Faculty/Resource person : Captain A. V. Samarth, Samson Freight Ltd.

Captain A. V. Samarth explained that the Customs procedures are the set of managements and operations that are carried out related to a specific customs destination, when you want to import or export a certain merchandise. Goods are imported or exported in India through air, sea, land. Goods can come to India through baggage with customers. Procedures generally vary with the mode of import and export bill of entry. He explained the import general manifest, passenger and crew arrival manifest, grant of entry inwards by custom officer, unloading payment of duty.

Export procedure are entry of goods for exportation export declaration export manifest/export, report entry outward no conveyance to leave without written order clearance of goods for exportation difference b/w transit and transhipment.



#### Session -5 to 9

Topic: Opportunities and challenges in Agriculture Export, Agriculture Export procedure and Documentation, Traceability net system for Pesticide Residue assurance for Export and farm registration procedure, Importance of Geographical indication, current status and future scope for export Faculty/Resource person: Prof. Govind Hande, State Level Technical Advisor Export Department of Agriculture, Pune

Prof. Govind Hande had taken four sessions in the programme. He covered the topics (i) opportunities and challenges in Agriculture Export, Agriculture Export procedure and Documentation, net system for Pesticide Traceability Residue assurance for Export and farm registration procedure, (iii) Importance of Geographical indication, (iv) Current status and future scope for export.

In these four topics he covered the detailed agri export process and the role of cooperatives in the agri export with the help of many examples.



#### Session -10

Topic: Profitable import-export businesses
Faculty/Resource person: Mr. Abhijit Shinde, Founder, Export Import
Federation

Participants of this programme got the opportunity to interact with the person who is actually dealing with the export. Mr. Abhijit Shinde briefed participants about the foreign markets. Scope for the cooperatives in the export business. He explained that cooperatives are having the producer group as members with them and it is the positive point for export business. He shared the success stories with the participants.



**Day 3: 10<sup>th</sup> January 2023** 

#### One day study Visit to (i) KSH Distripark, Talegoan

(ii) Horticulture Training Centre, Talegoan

#### (i) KSH Distripark, Talegoan:

The Study visit was arranged on 10<sup>th</sup> January 2024 for the participants to KSH Distripark, Talegoan to know the procedures followed for export of agri produce.

The important functions carried out in the KSH Distripark, Talegoan are (i) Anti Smuggling and Preventive work including of anti-narcotic functions – collection of intelligence, Joint Sea Patrolling, Night Road Patrolling, Patrolling of Coast / Creeks through departmental boats / vessels, Rummaging of cargo vessels. (ii) Assessment of Bills of Entry and Shipping Bills and related work at CFS Pimpri, ICD Dighi, ICD Pimpri-Chinchwad and coastal customs divisions at Ratnagiri and Dapoli (iii) enforcement of NDPS Act, 1985 (v) Marine wing operations at Ratnagiri and (v) manning of the telecommunications network in the entire Konkan area both in the inland region as also along the coast line starting from Bankot in the north to Kiranpani in the south.

#### (ii) Horticulture Training Centre, Talegoan

In the export market flowers like e Rose, Carnation, Gerbera, Anthurium, Lilium, Chrysanthymum & Orchids have high demand. To know the export of flowers study visit was arranged to Horticulture Training Centre, Talegoan on 10<sup>th</sup> January 2024 afternoon.

The Maharashtra State Agricultural Marketing Board, Pune has established a full fledged Post Harvest Technological Institute in the year 1993 and subsequently got registered as Non Government Organization (NGO) under the Society Act, 1860 on 10.12.1998 and as a Trust under the Trust Act, 1950 on 12.1.1999. to address the post harvest issues facing the farming community. Since its inception, the institute has been continuously engaged in carrying out practical and applied training, research and technology development work. Under the NIPHT, a specialized Horticulture Training Center (HTC) has been set up with financial support from MSAMB and the Netherlands Development Finance Company of the Netherlands Government along with technical support from the Practical Training Center Plus (PTC+) of the Netherlands. HTC is presently engaged in conducting short duration practical training programs of one week in high-tech horticulture.

#### **Session -11**

Topic: Initiatives of SMART project for agri export Faculty/Resource person: Dr. Abhay Gaikwad, SMART Project, Pune

Dr. Abhay Gaikwad explained about the Hon. Balasaheb Thackeray Agribusiness & Rural Transformation i. E. SMART project. It is the project, supported by the World Bank Group and the Korea-World Bank Partnership Fund, is focused on supporting the development of inclusive and competitive agri value chains

SMART project is committed to establish the SMART AgTech Integration Facility to help farmers and their Maharashtra collectives in access innovative technologies. The Bootcamp is an important step in building partnerships between DAT solution providers and Community-Based Organizations (CBOs) to enable farmers to access more lucrative markets and achieve greater economic returns.



#### **Valedictory Session**

Valedictory Session of the training programme was graced by Dr. Hema Yadav, Director, CICTAB & VAMNICOM in presence of Dr D Ravi, Consultant, CICTAB & CICTAB team.

Director shared that cooperatives should take part in the agri export and help their members for export and documentation. Government and Ministry of Cooperation are also supporting the cooperatives for export. National Cooperative Exports Limited (NCEL) was conceptualized and now it is serving as an umbrella organization in the country for exports from the cooperative sector concurrently. NCEL will promote exports through various activities including procurement, storage, processing, marketing, branding, labelling,

packaging, certification, research & development, and trading of all types of goods and services produced by cooperative societies. The NCEL will also help in arranging finance, provide technical guidance, help in training and capacity building, develop and maintain market intelligence system. Implement related government schemes and undertake any other such activities which will increase exports from the cooperative sector and other related entities.
